A Comprehensive Approach to Security

Security is integrated throughout the operation - from chauffeur qualification and employee screening to affiliate oversight, trip visibility and ongoing accountability.

1) Rigorous Chauffeur Screening

Affiliate partners are required to conduct driver background reviews at least every six months, including driving-record and criminal-background checks. Drivers may not have a history of DUI/DWI, significant preventable accidents or a pattern of repeated moving violations.

2) Employee & Information Security

Commonwealth employees undergo background screening, including criminal background checks. Employees with access to passenger itineraries use password-protected systems and unique logins, while reservation activity is recorded through detailed, timestamped audit trails.

3) Carefully Vetted Global Partners

Commonwealth's global affiliate network has been built over decades, with many partner relationships spanning more than 20 years. Affiliates are expected to maintain required licenses, permits and appropriate commercial insurance.

4) Real-Time Trip Visibility

Live GPS tracking is available on more than 90% of trips. Chauffeur Direct notifications are provided approximately two hours before pickup and can include the chauffeur's name, cell number, live tracking link and driver photo when available.

Partners are required to maintain operating licenses and permits, appropriate commercial insurance, and to notify Commonwealth immediately of license suspensions or regulatory action.

Affiliates must provide documentation upon request concerning driver qualifications, vehicle compliance and insurance coverage.

Incident accountability

Affiliate partners are required to cooperate fully in incident investigations, including identifying root causes and implementing corrective actions when necessary.
